APPROVED HAND PUMPS

THE HAND PUMPS LISTED BELOW MEET THE REQUIREMENTS OF RULE 153 OF PART 127, ACT 368, PA OF 1978, MICHIGAN'S GROUNDWATER QUALITY CONTROL ACT AND MAY BE USED ON PUBLIC OR PRIVATE WATER SUPPLIES. THESE HAND PUMPS HAVE A CLOSED SPOUT, DIRECTED DOWNWARD, AND A PUMP ROD THAT OPERATES THROUGH A STUFFING BOX AND PACKING NUT.

*THESE HAND PUMPS USE THE DROP PIPE INTO THE WELL AS THE PUMP BASE OR MAY BE THREADED ONTO A 2" WELL CASING BY USING A 2" X 1 1/4" REDUCER. IF THE DROP PIPE IS USED AS A PUMP BASE, THE OPENING BETWEEN THE DROP PIPE AND WELL CASING MUST BE SEALED USING A WELL CAP BASE AND SANITARY WELL SEAL.

**THESE HAND PUMPS INCLUDE A SHROUD WHICH PROVIDES ADDITIONAL SANITARY PROTECTION BY ENCLOSING THE PUMP ROD AND PACKING NUT.

+THIS PUMP OPERATES WITH A ROTATING PUMP ROD AND HAS A HAND OPERATED GEAR BOX RATHER THAN A LEVER-FULCRUM TYPE HANDLE OPERATING A RECIPROCATING PUMP ROD THROUGH A PACKING NUT.
