Committee members do not support increasing the salaries of elected officials in order to offset the cost of the increase in health insurance. The only increases supported are for the Clerk as a result of the combination of the Clerk and Register of Deeds offices, and the Sheriff to put him ahead of the Undersheriff. Questions were raised regarding the Chief Deputies receiving the 2% increase. Administrator/Controller Overton explained that the Chief Deputies salaries are to be set by the Board, although this hasn't been done in the past. Recommendation that this be put into a policy so these issues don't happen again.

Chairman Shotwell asked that if the committee does not recommend an increase for the other elected officials that they at least be forwarded to the full Board with a negative recommendation so that the entire Board has an opportunity to vote on this issue. carried.

negative recommendation for salary increases for the offices of Treasurer, Prosecutor, and Drain Commissioner. Motion carried.
