**IV - ADMINISTRATION**

**A. Freedom of Information Act (FOIA)**

**Charges for Information Request**

Only requests presented in writing, including facsimile or e-mail, will be accepted.

Actual costs for copying, postage and retrieval shall be charged for FOIA requests. Labor costs will be assessed based on the hourly wage of the lowest paid public employee capable of retrieving the information necessary to comply with the request. Costs shall be determined by the Elected Official or Department Head responsible for retrieving the information. The decision to waive fees shall be determined by the FOIA Coordinator.

If it is estimated that costs will exceed fifty dollars (\$50) a good faith deposit of up to one half of the total estimated cost may be requested prior to processing the request.

FOIA requests shall be considered communications and copies shall be forwarded to the County Clerk for inclusion as Communications on the next Board of Commissioners Agenda.

**B. Non-Sufficient Funds (NSF)**

A \$35.00 charge will be assessed for any check returned for non-sufficient funds

**C. Disinterment/Reinterment**

A \$10.00 charge will be assessed for issuance of a Disinterment/Reinterment Permit.
